THE GRANDE AT CANAL POINTE MAINTENANCE CORP POOL RULES- 2023

- The pool is unguarded, and use of the pool is at your own risk
- Pool Hours (subject to change)
 - May 26 June 19
 - 10:00am to 6:00pm
 - June 20 August 20
 - 10:00am to 6:00pm (Monday Thursday)
 - 10:00am to 8:00pm (Friday Sunday)
 - o August 21 September 17
 - 10:00am to 6:00pm
- A fob is required for entry
- Number of persons per house maximum of (12) persons per unit; (6) people per fob
- Owners, guests and tenants must sign-in and provide the required information upon every visit. The pool attendant is authorized to ask for identification from any individual; owners, guests and tenants must provide identification upon request
- All children under the age of (14) must be accompanied by a person (18) years of age or older and that person must always be in the pool area
- No floats, rafts or pool toys are permitted; noodles are allowed Inner tubes, water wings and Coast-Guard-approved life jackets/vests are permitted on children and the parent or adult must be present in the pool with them and at arm's reach
- Food and beverages are permitted but no glass containers and no food or beverages in the pool. All food and beverages must be consumed at least six feet (6') from the pool edge. All patrons are asked to clean all areas used for food and beverage purposes and to dispose of all associated trash in the proper trash dispensers
- No animals, except for guide animals, shall be permitted in the pool area
- The throwing of any object (balls, toys, rings, water bottles, etc.) is strictly prohibited
- The use of audio equipment is not permitted in the pool area, except for use with earphones
- Smoking, vaping and/or tobacco chewing is strictly prohibited in the facility and pool area; a designated smoking area is available outside of each facility
- No hanging towels and other garments on the fences
- No playing on the steps or handrails of the pool or on or around the pool ropes
- All deck furniture must be a minimum of (3) feet from the edge of the pool
- No running, horseplay or use of offensive language is permitted at any time
- No skateboards, scooters, bicycles, wagons, etc. permitted on pool deck

At the sole discretion of the pool attendant(s), management and/or the pool maintenance contractor, the pool may be closed at any time for safety and/or mechanical issues and/or should chemical balancing be necessary.

Enforcement of pool rules is important to make the pool a safe and enjoyable experience for our community. The pool attendants have been instructed to report all owners not abiding by the rules, or refusing to abide by them, directly to Property Management and the Board and appropriate action will be taken. This could include asking parties to leave the pool for the day and/or suspension of pool privileges for a prolonged period of time.
